PRESIDENT'S OFFICE

The meeting was opened by the President, Bill Gale, at 7:15 P.M.  
The minutes of the previous meeting were read and approved.

Mr. Gale read the following letters:

1. From Mrs. Kirby acknowledging the flowers which Student Council sent to her during her illness.
2. From Dr. Franzen in Germany telling of his work there.
3. From Pratt Institute asking for a copy of our freshman handbook. Anne Ford will see Mr. Buker in the Junior Division.
4. From the Student Senate at Purdue asking for information on our cooperative food store. Charles Brown will hand this letter to the Woodlawn Courts representative on the junior assembly.
5. From Adelphi College in Garden City, New York, concerning a fine arts workshop. The letter will be turned over to Delta Tau Mu.
6. From Tulane University stating that their proposed conference would not be held.
7. From the I.S.A. asking for a poll on student government.
8. From Mr. Frank Franklin concerning the action taken on Junior Assembly recommendations. The letter will be turned over to the Junior Assembly.

#### OLD BUSINESS:

Bill Gale will contact Nat Whittenberg about bills for Room 311 of the Union Building before the Council takes any ~~etc~~ other action.

The food price list for the Union has been handed to the Student but has not been published yet.

#### NEW BUSINESS:

The letter from the I.S.A. asking for a poll from the students on student government was again considered. Charles Brown made the motion that: the Student Council accept the suggestion proposed by I.S.A. and that the president of the Council appoint one or more members of the Council to consist of a committee charged with carrying through the suggestion as it sees fit. Anne Ford seconded the motion. Charles Brown amended the motion to read: the committee shall make a preliminary recommendation and submit the plan at the next Council meeting for approval. Anne Ford seconded. Amendment and motion carried. Chet Anderson will secure assistance from the I.S.A. and present the questionnaire to be sent out at the Council meeting, April 8th.

The action of INDAC was brought up, but it was mentioned that since the letter from INDAC had already been turned over to the administration, the Student Council will await information from that office.

Gene Koger, chairman of the Elections Committee, asked members of the Council to be present at the polls on April 2nd and to help count votes at 5:00 P.M. for the Junior Prom Queen.
