June 9th 1874 Fac. met at 2 P.M. Prof. Leese absent, Prayer by Dr. Owen, Min. adj'd. On motion the resignation of the 2^d honor on the part of Mr. F. K. Beck was accepted, no provision to supply the place of Latin Salutator was made, Three representatives of the Junior Class coming before the Faculty presented a written apology from the class for its part in the late conflict between Senior and Junior classes, Mr. J. W. Jefferson being called in to answer to the charge of shooting Mr. J. A. Montgomery, and "other disorderly conduct, on that occasion presented a statement going to invalidate the testimony against him in court, and also stating that while he discharged his revolver six times, he did not think that he shot Mr. Montgomery. On motion the whole subject was laid on the table till next meeting. Petition of Chorus to the Board of Trustees for a new Organ for chapel worship being presented Faculty resolved to endorse the recommendation in the Annual report, Application for degree of L. L. D. from Pres. Daul Reed for his brother of Terre Haute being read was laid on the table, and the application for degree of D. D. for Prof. Jeffrey of Worcester Ohio was similarly disposed of.

Motion that class. Day exercise for this com^t be omitted was laid on the table till next meeting. After some discussion of the question of whether the young ladies should be required to obtain permission of Miss Morrison before going out at evening in a capacity representing the University faculty adjourned.

June 11th 1874 Fac. met at call of Pres. Opened informally, Called Meeting Mr. Spicer was called in and made some statements with reference to the shooting of his dog on the night of the Senior Serenade, Pres. to see Mr. Laughlin and advise him to take Classical Course. but if he decides still to continue a scientific to inform him that the faculty consent to the substitution of two terms of Greek for two terms of Latin, Faculty proceeded to consider the discipline in the case of the late disturbance between Sen & Jun. classes.
