The Pres. presented the petition of certain members of the Senior Class, appointed to speak at Commencement, to be granted a vacation from May 19 to Commencement day. Petition was on motion of Prof. Boone refused.

The Pres. and Sec. were instructed to request on behalf of the Faculty the appointment of Wm. Hailman of LaPorte as one of the two Indiana Commissioners for the World's Fair at Chicago in 1893.
