- 1. No man shall be eligible for selection unless he shall have completed three-fourths of the required number of credit hours one month prior to the date set by th constitutions for the meeting of the qualifications committee.
- 2. The chairman of each serving committee shall keep a record of the credit hours worked by each service worker on his committee. He shall supply each service worker with a signed memorandum of same and submit a duplicate to the chairman of the Merit System Committee within five days after the chose of each calendar month for a permanent file.

A chart showing the name of every service worker shall be posted in Room 2. The chart shall contain divisions showing a monthly record of the credit hours of each worker. Credit hours shall be recorded by the chairman of the Merit System Committee within ten days follow the close of each calendar month.

4.A call for service workers will be issued at the beginning of each school year. Both old and new workers will be required to signify their intention of continuing or beginning as service committee workers.
