Roll Call: Cogshall, Higdon, Richardson.

Minutes were read and approved.

Sturgeon reported on Chess Club. The program was planned until April. He was making a complete record of the Chess Club from the beginning to the present time. He suggested that a Board member be in charge of the club, but to have a metit worker, Fred Case, to work with the member.

Boughman reported on the dance committee. 85 boys turned out for first dance lesson last Wednesday. These lessons will be given in Rooms A. B. C. D. On Saturdays, February 25, the first Mixer will be held from 3 to 5 P.M. in Alumni Hall. Music will be provided by the phonograph. The Sweater Swing will be tomorrow night, Feb. 17, as a regular Friday night Union-A.W.S. dance. A free ticket will be given away for the next dance.

The Flying Club report was given by Baughman. The club met Monday Feb. 13. This club applied for membership into the National Collegiate Flying Club. Col. Cook hopes to be at convocation, Mar. 11.

Thomas reported on the Basketball Banquet to be held on March 13. Other members of the committee are Visher and Clorson. The speaker for the banquet will be Bill Ross, sports editor of the Indianapolis News.

Visher stated that the next Town Hall program will be Sunday, Feb. 19, at 7:45 P.M. The religious group of the campus will have charge of the program.

Thomas and Lawrence reported on the counseling system. A short discussion was held.

Fleming directed Thomas to write a letter to Genieve Senifield of the AWS stating that the Union felt that it was entirely out of our hands to council the students on an academic basis. Lawrence and Thomas are to further investigate the mental hygiene clinic.

Lawrence reported on the Record Hour. 125 persons attended. The Orgaton concert will be held in Alumni Hall on Sunday afternoon Feb. 27, Friday night, March 3, instead of the Record Hour.

Patrick reported on March 19, Sunday afternoon, Fray and Braggiotti and Rubinoiff will play a concert here under the sponership of the Indiana Union.

Fleming entertained a motion that this program be given full support. It was moved and seconded by Mauck and Sturgeon respectively. The motion was carried unanimously.

Anderson and Smith were appointed to serve on the committee for the program publicity for this program.

Prof. Robinson suggested that we have some type of a program



honoring the 30th Anniversary of the founding of the Indiana union.

Sturgeon retired from active Board meetings due to ill health, and his having to withdraw from the university.

Sturgeon moved we adjourned, seconded by Boughman. Meeting adjourned to the Commons. At the time Sturgeon treated the members of the Board to chocolate frosts. Adjourned at 9.30.

Thomas reported on the University of Ill. Counseling Service.

Lawrence reported on the Record Hour.

Anderson reported on Billiard Room Conditions, and he offered the suggestion that a Billiard League be formed to increase the number of patrons of the Billiard Room.

Fleming introduced the discussion of the elections of Faculty Honorary Directors to the Board. In view of the fact that Prof. Robinson has been unable to attend regularly it was suggested that perhaps a different meeting night be used to accomodate him.
