

September 27, 1943.

Meeting called to order by Wolf.

Roll call: Turner absent.

Minutes read and approved.

McCarty reported that the complimentary dance September 25 was attended by 1200 couples.

Radigan moved that complimentary dances be held on October 9 and 30.
McCarty 2nd. Carried.

Wolf announced committee appointments:

Wiggins: Records, Billiards, Chess.

Turner: Special Projects, Posters, Tickets, Campus Calendar.

Howard: Guide Service, Building Personnell, Ushers, Forums and Convocations.

McCarty: Social Chairman, Publicity.

Radigan: Pep, Cheering, Sports, Gridgraph.

Wolf suggested that the Union-AWS open the formal season on November 6 and instructed McCarty to investigate bands and public opinion.

McCarty moved to change the present Social Affairs Committee ruling in regard to social functions conflicting with Union Dances. Wiggins 2nd. Carried. The Board decided to send a recommendation to the Committee to the effect that "conflicting social functions may be held on those nights when there are Complimentary Dances but not on those nights when paid-attendance dances are held."

McCarty moved that no pep session be held on Friday, October 2, because no band was available. Howard 2nd. Carried.

Rich reported on committee meetings in regard to homecoming plans. Radigan was appointed to represent the Board on the homecoming committee in regard to the parade, bonfire, and auditorium program.

The Board decided to run the Gridgraph during the Nebraska game on October 9.

Radigan moved to hold the quarterback hour each Wednesday evening, the hour to be set at a later date. McCarty 2nd. Carried.

Wiggins moved that the Board recommend to the homecoming committee that classes be suspended on Saturday, October 23.

Howard reported a need for ushers during auditorium programs and recommended that the student body be contacted in regard to Union service workers, through letters to fraternity presidents and publicity in the Daily Student.

Rich suggested that the Board contact the Purdue Union in regard to chess and checkers club. Wiggins was instructed to investigate the possibility of a billiard tournament and to report on chess, checkers, and records.

Howard was instructed to contact Dr. Frank O. Beck in regard to an open forum and Town Hall.

Radigan presented a suggestion that the Board sponsor a radio broadcast from Alumni Hall twice weekly contain news of world affairs, ASTP, and campus activities. Board decided not to take any action unless a specific college department decided to back such a program.

Rich reported that the Dugout will be redecorated.

The Board decided to buy two pages in the Arbutus.

McCarty moved to adjourn. Radigan 2nd. Meeting adjourned.
