May 14, 1945

Meeting called to order at 1:35 p.m. by Leakey.

Roll call: Murray absent.

Minutes were read and corrected.

Kyle reported: There is a possibility that the Union-AWS Social Committee will sponsor an excursion to McCormicks Creek or Brown County for the students. A dance will be planned as soon as it is seen that there is a genuine interest and desire for a dance. This is in order to assure we do not take a loss on the dance.

Kluter reported: A list was turned in on all men who have 25 hours or more. The list has been posted on the bulletin board in the Men's Lounge.

Mr. Smith reported that the Record Hour Committee will meet Wednesday at 7:00 p.m.

Leakey mentioned that Record Hour will be held on Thursday of this week in order to avoid a conflist with Convocation which is scheduled Friday evening

It was decided to print the names of those who have received the Indiana University Union Service Award on a card to be placed on the bulleting board in the Men's Lounge - in a plaque form.

May 22, 1945

Meeting opened at 1:30 p.m. by Leakey.

Roll Call: all present

Minutes read and approved.

Kyle reported: An all-campus picnic to Brown County has been planned by the Union-A.W.S. Social Committee for Wednesday, May 30. A charge of \$1.50 per person will include transportation, lunch and admission to Park. A Terrace dance has been scheduled for Saturday, May 26. Refreshments to be sold on second floor.

The Dugout will be open for dancing, etc. from 8:00 p.m. until 12:00 m. on June 2.

Mr. Whallon was ready to co-operate in having the Auditorium open on Sundays but thought it not advisable until after the War. He stated there is a need for at least four trained ushers to show people around the Auditorium and it is not possible to find that many people who will devote their Sunday afternoons to the project.

Kyle moved that the matter of the Auditorium be dropped until further developments. Seconded by Kluter. Motion carried.

Kluter reported: A notice has been given to the Student calling for service workers. Service workers will be in charge of signing up new workers at the Lounge Desk from 1:30 to 5:00 p.m. A pamphlet on Merit Service is planned to be distributed at the Freshman banquet this fall. Kyle made a motion and Kluter seconded it that work be started on this pamphlet. Motion carried.

Mr. Smith reported: The Record Hour Committee found that 28 records have been broken or missing. The Committee decided to cut down the hours of playing and have records checked out only at Lounge Desk on Saturdays from 1:00 p.m. to 5:30 p.m. and on Sundays from 1:00 p.m. to 6:00 p.m. Service Workers will be in charge of checking out the records.

Kluter moved that the meeting be adjourned. Kyle seconded the motion. Carried.
