The minutes of the previous meeting were read and approved.

#### Committee Reports:

Social--Jones reporting: The Skating Party plan was taken up before the Student Affairs Committee and rejected. The Dugout was open last Saturday and was pronounced successful; it will not be open this week-end. The Social Affairs Committee passed the plan for opening the Commons on Wednesday nights. The Dugout will be open on Wed. nights.

Personell--Duncan reporting: The office force was informed of its duties this afternoon at a special meeting.

Records--Steckler reporting: About 65 people attended last Friday's record Hour.

Chess--Duncan reporting: Only 3 people attended the meeting last Thursday. Unless more interest is shown, the Club may be discontinued.

Bridge Tournament--Elsner reporting: All housing units have been contacted and have agreed to hold eliminations in their respective houses. The semi-finals will be held on or before the 5th of April, and the finals will be held on or before the 12th of April. Elsner requested a plaque for the winning male team.

Dean Bates suggested that in view of the fact that we are using the Dugout it should be redecorated. Duncan suggested that a different group be put in charge of decorating the Dugout every week.
