

April 29, 1947

Meeting came to order at 7:00, Pres. Wallace presiding.

The minutes were read and corrected.

New Business:

A Mr. Yover appeared before the Board to speak on the Med Boress. He asked us to indicate to the Dean of Students that we were not in favor of such performances. A lengthy discussion followed, and it seemed to be the general consensus of opinion that the Boress was out of order. However, there was some disagreement as to whether or not the Union Board should request the authority to prevent such actions, and whether, if such authority were granted, the Board would be able to utilize it. No action was taken at the present time.

Social:

The last Union-A.W.S. dance is to be a record dance Friday, May 2. It was requested that Board members put in an appearance.

Town Hall:

The next forum is to be Sunday, May 4.

Hiking, etc.:

Patton discussed the history of these activities. Interest has dwindled in these activities, largely due to the fact that many of the chaperones interested have been removed from the approved list. It is the aim of this committee to restimulate interest in these activities.

Photography, etc.:

Traub reported that the Photography Club complains that they have to pay for everything themselves. Mr. Smith explained that Union Board furnishes equipment and that some should be in soon.

Record Hour:

The committee plans to add a Wednesday night hour for popular music in addition to the Friday night classical hour.

Bridge, Chess, and Bowling:

The Bridge Tournament is to be Thursday, May 1. As yet, there are very few entries.

Personnel:

Graves explained his proposed program which includes these points: requests for routine work are to go through the Personnel Office. Members are to sign all hour receipts; duplicate copies are to be kept to prevent records being changed; and a list of all service workers free at each hour is to be kept.

Publications:

The committee is to publish a weekly news bulletin.

Publicity:

Copies of the sheet written up in accordance with last week's suggestion were shown and approved for distribution.

New Business:

Members made appointments with Mr. Smith to determine their budgets.

Service Hour Committee:

Two of the members made a report. They recommended that there should be no cut in the hours given for ushering, but moved that a minimum of 25 hours be obtained under activities excluding ushering to be eligible for selection or service awards. Husband seconded. After discussion, motion was defeated 8 to 6. Traub moved that a minimum of 15 hours be obtained under activities excluding ushering to be eligible for selection or service awards. Fague seconded. Motion passed unanimously.



Student Union Committee:

Mr. Smith explained the new building program to which women students are contributing the same as men. Lambert told about other schools, representatives of which he talked to at Illinois. Fague then asked that all questions concerning this be turned in to Mr. Smith's office by 6 P.M. Wednesday, April 30.

New Business:

The Special Events committee is to arrange for the Freshman Smoker next fall. Lambert moved that the smoker be held the latter part of orientation week. Fague seconded. Motion carried unanimously.

Mr. Smith called attention to the traditional Union Board reunion. Fague moved that it be held. Graves seconded. Motion passed unanimously.

Constitution Committee:

No report made at the present time.
