President Wallace opened the meeting. The minutes of the last meeting were read and approved.

Committee Reports

McMahon outlined summer activities for the social committee.

Toy made a report on the proposed intertainment file as follows:

1. Union Board will book bands and make Alumni Hall available. Entertainment file should be obtained by sending out letters and questionaires to all expected intertainers.

2. Decoration and program file covering every event held will be established .

3. Decoration committee for organization of dances by Union Service workers will be created.

4. A report from each organization holding a dance will be requested explaining the details of the dance and program.

Bakerpresented the Bridge Committee report which was accepted

and filed.

Toy proposed an advanced Union Service Award which would take the form of an organization of the Union Service workers to present ideas to Union Board. Toy moved this organization be conducted under the supervision of the Vice-President of the Board. Motion was tabled.

McMahon reported that 18% of the men on campus have attended two or more Union-A.W.S. dances this semester. Also 85% of the

campus men liked the "pop" concerts.

Powell read the dance contract as drawn up by Dr. Luskand moved it be accepted by the Board as read. The motionwas seconded and carried by an 8 to 1 vote.

Edwards reported that Union membership cards had been read and approved by Mr. Franklin and Mr. Jordan and moved he be delegated to distribute cards at enrollment time. Motion seconded and carried.

Toy moved that Union Board recommend to the administration that a pep session be held during class hours next fall. Motion

seconded and carried, 7 to 2.

Toy's motion which gave free dance tickets to all members of the Board for all danced held in Alumni Hall was then brought to the floor and discussed. The motion was brought to a vote and carried 7 to 2.

Wallace then brought the Fall Carnival to the attention of the Board. Steckel was delegated to send an invitational letter to all campus organizations. Moss was appointed chairman of the carnival.

Lyman Smith gave his yearly financial report and moved acceptance of same. Motion carried.

Steckel moved Smith, Wallace, and himself be in charge of scheduling 'pop' concerts during summer. Motion seconded and carried.

Moss moved adjournment. Seconded and carried. Meeting was adjourned.
