The first pep session will be held Octoberl at 6:15 p.m. Also, on Thursday, September 23 at 7:00 p.m. cheerleader tryouts will be held in the Men's Lounge of the Union Building. Singing at the games will be emphasized this year with a "Know your Songs" week.

Recreation: Baker reported the organization of the Bridge Tournament games which will start September 30.

Edwards told of the Fall Festival and Baker reported on the Freshman Smoker. Both events were well received by the students. Toy moved a vote of thanks be given Edwards and Baker for their fine work on the Fall Festival and the Freshman Smoler. Motion carried.

Personnel: Schaerer announced that office is now open and files will be kept to explain events sponsored by the Board. Also publicity will be given to the newly established entertainment file.

Carnival: Moss explained the rental system for the carnival booths. The floor plan will be ready September 23. Also the "Bachelor of the Year" contest was explained by Myers who is handling the event. Edwards, McMahon, and Baker told of their jobs and how they were progressing. The publicity of carnival will include radio spot broadcasts, posters at the Iowa game, and don campus, and full coverage by the "Student" and local newspapers.

Wallace called the Board's attention to the fact that a selection of two men to fill the vacancies left by Peterson and Dunham would have to be made after the carnival. A Qualifications Committee headed by Bob Schaerer was appointed. Nominations were then in order for a Board member to sit on the selection committee.
