

Mr. Bucher asked the Board to consider the problem of getting information to freshman concerning participation in campus activities.


The Board will meet Thurs., Jan. 24, at 9:00 a.m. to consider the new Student Union Constitution.




The President instructed Fred Pain to send copies of the proposed constitution for the student Union to all large organizations on campus, as well as to various officials in the administration.

The twenty-fourth meeting of the 1951-52 Union Board was called to order by the President at 7:05 p.m., and the minutes of the last meeting were read and approved. Mr. Bucher, Jerry Baur, Dick Hensel, and Bob Weather were absent.

The President reported that Dean Ashton, Col. Shoemaker, and Mr. Franklin met last Fri. to consider the proposal of AWS concerning an impartial selection of a committee to write a new Union constitution. These three recommended that the same students continue working on the constitution together with a group of faculty and staff members if the Union Board and AWS Council approve.

The selection of the new Board for next year begins in two weeks.

Mike Hreha moved that service hours be granted for men who usher at programs in East Hall. The motion carried unanimously.

Fred Pain announced that Town Hall will hold a forum Sun. concerning the proposed Student Union. He also stated that the tape recorder that was acquired was not good enough for radio recording.

Jerry Wilson reported that attendance in the Rhythm Room has been slack, and that shows are planned for the future to help draw customers, including a faculty talent show some Sat. The Union-AWS fund now has \$1,702.00.
