Geist announced that all recommendations for the Distinguished Service Award for seniors are due next week.

Also Schnell announced that the date for the election of the three remaining board members is to be announced next week.

Carol Creed told the board members the results of the Mardi Gras -- we made a small profit. She stated that the pictures of the composite picture for the board members were in her possession to be purchased at any time. Also she announced that Margaret Norton will be visiting the meeting next week.

Schnell announced that he is sending a man around to get information covering the highlights of each division for an analysis for the Daily Student.

The meeting was adjourned.
