## Prominent U. of Chicago Law Professor Speaks At Law Journal Banquet

Karl Llewellyn delivered a speech on "Your Profession at Home" to the staff their wives, alumni, and other guests on March 21 at the Van Orman Hotel.

Mr. Llewellyn is Professor of Law at the University of Chicago. His major fields of interest are commercial law and jurisprudence in both of which he excels. He has been a draftsman of various uniform commercial acts and is co-author of **The Cheyenne Way**, a work basic to any study of primitive law.

Professor Llewellyn emphasized the intangible benefits accruing to lawyers and discussed the responsibilities of lawyers in non-legal capacities. He illustrated the craftsmanship of attorneys by using an example of how various conflicting interests are resolved in a family situation.

Approximately ninety persons attended the banquet which is the annual highlight of Journal activities. Bob Miser, Senior Associate in charge of note topic research, served as general chairman of the banquet.



## OVER 200 HEAR HALLECK SPEAK AT LAW DAY BANQUET, MAY 1

The Honorable Charles A. Halleck, LL.B. '24, keyed the annual Law Day sponsored by the Law Club in connection with national commemoration of that day.

Activities for the "day" included Mr. Byron Kennedy's speech the evening before, the freshman-upper classmen softball game, moot court competition and the banquet at the Van Orman-Graham Hotel. The banquet featured awards to outstanding students and presentation of the Gavel Award and was highlighted by Representative Halleck's speech.

Judge James A. Emmert, former Indiana Supreme Court Judge, introduced Representative Halleck. Representative Halleck departed from his prepared speech on "The Problem of Federal Preemption" and delivered instead a more informal address dealing with current political problems and more light-hearted reminiscences of his collegiate days here at Indiana University. Federal preemption was mentioned however, with Representative Halleck declaring that courts should find such preemption only when Congress has made its intent to preempt clear, and that Congress has the duty to enact new legislation when it feels the courts have misinterpreted its intent.

The banquet was attended by about 200 honored guests, faculty members, students, wives and dates.

As a prelude to Law Day activities, Mr. Byron C. Kennedy of Rockhill, Vander-veer, Kennedy and Lee of Warsaw, Indiana spoke to students April 30 on specific ethical problems confronting attorneys.

Mr. Kennedy was elected Judge of the Wabash circuit court when he was twenty-seven, and served fifteen years. He has been associated with his present firm since 1956. He is a 1928 graduate of the Indiana Law School, now the Indianapolis Division of the School of Law.

## News Of The Law Journal

## Harris Lectures Feature Outstanding American And English Law Professors

Comparative Law was the theme of this year's Addison C. Harris Memorial Lectures. The lecture series is made possible through the generosity of Mrs. Harris who established the fund in memory of her husband, a prominent practitioner in Indiana.

Frederick H. Lawson, Barrister (Gray's Inn) and Professor of Comparative Law at Oxford University was the initial speaker; his topic was "The Approach to French Law." Professor Lawson is currently Visiting Professor at the University of Pennsylvania.

"The Approach to German Law" was delivered by Max Rheinstein, Max Pam Professor of Comparative Law at the University of Chicago. He is a member of the International Academy of Comparative Law and the German Society of Comparative Law.

A "Comparison of Soviet and American Law" was the subject of Professor Harold J. Berman, the third speaker in the series. He has been a member of the Research Association, Russian Research Center, Harvard since 1948. Professor Berman recently argued a royalty case in the Soviet Union for Sir Arthur Conan Doyle's son, which was dismissed, but which may be appealed next August.

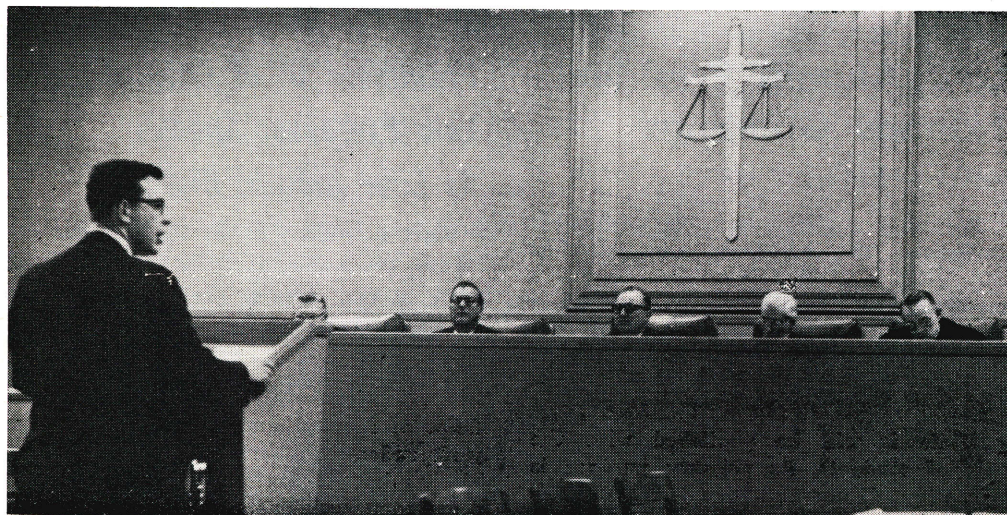
The last lecture of the series, "The Comparative Method in the Common Law," was delivered by Professor Ronald H. Graveson, Barrister (Gray's Inn), and Professor of Law at the University of London.

Professor Graveson is Dean, Faculty of Law, King's College, London. He also serves as Chairman of the United Kingdom National Committee of Comparative Law. Professor Graveson is Visiting Professor at Harvard this year.

The lectures this year were held in the Moot Court Room of the Law Building at Bloomington and were arranged by a committee composed of the following faculty members: Professors Clifford, Hall and Rutledge of the Bloomington Division, and Professors Foust and Mandelker of the Indianapolis Division. Informal receptions in the Common Rooms of the Law Building followed each lecture.

## INDIANAPOLIS WINS

The Indianapolis Division won the annual Law Day Moot Court competition between the Bloomington and Indianapolis Divisions. The Indiana Appellate Court sat as judges for the occasion.

This year's problem stemmed from a tort suit against an insurance company in Alabama. An aunt with no insurable interest took out insurance policies on her two year old niece. The aunt then put arsenic in a coke she served her niece,

from which the little girl died. Her father sued the insurance company for negligently issuing a policy to one with no insurable interest, obtaining a judgment for \$75,000. The primary issue concerned the applicability of the contract rule of insurable interest in the field of torts.

The appellants for the insurance company were Messrs. Fitzpatrick and Owens of the Bloomington Division. Messrs. Rhoads and DeTrude of the Indianapolis Division argued for the appellee father,

### Professor F. Reed Dickerson Meets Seminar

Mr. F. Reed Dickerson was appointed as Professor of Law at the Bloomington Division last fall. His courses include Legislation, Seminar in Legislation, Seminar in Land Use Controls, and Commercial Law.

He received his LL.B. from Harvard in 1934. In 1938 he enrolled in Columbia where he obtained his LL.M.; he received his J.S.D. from the same school in 1950.

Prof. Dickerson's teaching career began in 1938 as a lecturer at Northwestern University. Washington University at St. Louis then named him assistant professor. He next moved to the University of Pittsburgh in the same capacity until 1942. He also lectured at American University in 1956 and 1958.

The government obtained his services in 1942 when he served as director of pricing standards for the OPA until 1947. He served as assistant legal counsel to the

House of Representatives for the next two years. He then became deputy chief and chairman of the commission on codification for the Joint Army-Air Force Statutory Revision Group, Department of Defense, until 1956. He was assistant to the general counsel and deputy assistant general counsel dealing with codification until 1958, when he came to Indiana, having been in charge of the codification of Titles 10 and 32 of the U.S. Code.

Mr. Dickerson received the distinguished civilian service award from the Department of Defense in 1957. He is a member of the American Law Institute National Legislative Conference. Governor Handley has recently appointed him as an Indiana Commissioner on Uniform State Laws.

Books published by Professor Dickerson include **Products Liability and the Food Consumer** and **Legislative Drafting**.

## Bloomington Division Professors Contribute To Written Legal Scholarship

Distinguished Service Professor Jerome Hall's most recent book is **Studies in Jurisprudence and Criminal Theory** published by Oceana. This book was the subject of an article by Associate Professor Gerhard O. W. Mueller, Director of Comparative Criminal Law Project, New York University School of Law, printed in 34 **Indiana Law Journal** at page 206. The University of Buffalo has published his lectures on "Reason and Reality in Jurisprudence" which were given as its Mitchell Lecture Series. Professor Hall's debates at Harvard on "Mental Disease and Criminal Responsibility" appear in 33 **Indiana Law Journal** 212. The **North Dakota Law Review** of October, 1958 carries his article "A Law Teacher's Tour Around the World."

Professor Ivan Rutledge's book review appears in 34 **Indiana Law Journal** at page 138. His review was of **Studies in Jurisprudence: V. Free Man Versus His Government**, edited by Arthur L. Harding.

Professor F. Reed Dickerson has an article soon to appear in the **Rutgers Law Review** on "Group Interests in the Field of

Food Law." Volume 44 of the **ABA Journal** contains his "Legislative Drafting: American and British Practices Compared." The same article is to be printed by the **Cambridge Law Journal**.

Assistant Professor Maurice Kirk has completed his "Second Report to the Governor and General Assembly of Indiana on the Codification of the Indiana Common School Laws," which was published in November, 1958.

Professor Ralph Fuchs' address to the Association of American Law Schools, "The Proposed New Code of Administrative Procedure" has been printed by the **Ohio State Law Journal** in volume 19, page 423.

Professor John Bauman's article submitted to Columbia University toward his doctorate has been printed in 33 **Indiana Law Journal** 467. His work is "A Rationale of Summary Judgment."

Associate Professor W. Howard Mann's book review of **Essays on Constitutional Law** has been published in the **Journal of Legal Education**.

## Rutledge Receives Gavel Award At Law Day Ceremony

Each year the Senior class presents the Gavel Award to the non-student who has made the greatest contribution to the development of that class. Professor Ivan Rutledge received that distinction this year.

Mr. Rutledge has taught Administrative Law, Antitrust Law, Constitutional Law, Federal Jurisdiction, Trade Regulation, Criminal Law, International Law, Labor Law, Legal Writing, and Trial and Appellate Practice. Professor Rutledge's analytical approach and emphasis on use of legal principles and tools is perhaps his greatest contribution to our class, although his ability to correlate specific problems to their broader perspectives is no less important.

Previous Gavel Award recipients include John S. Hastings in 1948 and in the following years, C. Ben Dutton, Jr., Bernard Gavit, Alfred Evens, Miss Margaret Greene, Jerome Hall, Frank E. Horack, Jr., Leon Wallace, Herman Krannert, Miss Betty LeBus, and Austin V. Clifford.

## Bloomington Division Offers New Course For Third Year Students

A course in trial techniques has been added as a part of the Legal Techniques program inaugurated in 1956. The freshman course involves legal research and drafting problems. Second year students have the traditional appellate level moot court problem as well as other problems. This year the project was the drafting of articles of incorporation from a prior partnership in which one partner had deceased. The seniors this year have been assigned problems dealing with pre-trial and trial steps in advocacy. Problems from pleading to fact investigation to cross examination and motions for instructions have been included to help bridge the gap between student education and actual problems encountered.

The trial tactics program is under the direction of Professor Austin V. Clifford who practiced in Indiana and Chicago from 1922 to 1942. He served in the Army as a Captain and Major from 1942 until 1946 working with refugee and displaced persons' problems. He was with the prosecution in the 9th Army black market cases. Mr. Clifford has been a professor since 1946. He is assisted by Daniel Rotenberg who was in the Air Force JAG and by Frederick Franklin who was in the Attorney General's Honor Recruitment Program for two years, both Teaching Associates.

## News of Indianapolis Division – Faculty, Students, Alumni

Dean Henry B. Witham was recently elected Secretary-Treasurer of the Indiana Bar Foundation. He has completed a revision of Witham, **Selected Cases on Contracts Remedies With References to the Restatement of Contracts.**

Professor Cleon H. Foust was appointed by Governor Harold W. Handley to the Study Commission on Forensic Sciences. His Bill No. 381, **"To Create a State Commission on Forensic Sciences,"** was passed in the 1959 state legislature. Professor Foust also co-authored an article for the current Indiana State Medical Journal—"Some Medico-legal Aspects of Blood Extraction." In the April issue of *Res Gestae* appears his "The Lawyer and the New Forensic Science Legislation in Indiana." To be issued in book form is Professor Foust's Symposium on Alcohol and Road Traffic at Indiana University—"The Implied Consent Laws."

Professor John S. Grimes has just received from Bobbs-Merrill the 3rd and 9th Volumes of his revision of **Thompson on Real Property** and **IIIA** was just released. He completed and published biennial supplements to **Thompson on Property**, **Thompson on Wills** and **Henry's Indiana Probate Law**. At present he is completing work on the **Law of Surveying and Boundaries** based on **Clark on Surveying** and revision of **Thompson, Volume IV** is now in process.

Professor Lester B. Orfield was on sabbatical leave the first semester 1958-59 and did research work in the Scandinavian countries. He also lectured at the Universities of Lund and Stockholm. He was granted a \$1500 award by the Social Science Research Commission of New York City for a study of health insurance laws of the Scandinavian countries.

Professor Ben F. Small is still flying each Monday to and from Washington

University at St. Louis, Missouri, to teach "Constitutional Law." The assignment was for the past and present semesters. He was named by Indiana's Governor Handley as an Indiana Commissioner of Uniform State Laws, and was elected this spring to membership in the American Academy of Forensic Sciences. He recently completed the 1958 Supplement to Small's **Workmen's Compensation Law Of Indiana**; Chapter 1 on "Causation" in Moritz & Helberg's book, **Trauma and Disease**, and "The Heart Problem in Workmen's Compensation," *Journal of the Indiana State Medical Association* for February, 1959.

Professor R. Bruce Townsend is currently revising the casebook materials for his course, "Commercial Law," which was added to the curriculum and taught the first semester, 1958-59.

Associate Professor Daniel R. Mandelker will begin his sabbatical leave in September. He has been awarded a Ford Foundation grant which will extend his leave through the Second Semester, 1959-60. He and his family will reside in London, England, where he will undertake a study of the administrative operation of English planning law governing development of land and control of land use.

Assistant Professor Charles D. Kelso is presently on sabbatical leave in Miami, Florida, University of Miami, doing research for future publications. He has the following works on the presses: **Washington University Law Quarterly**, "The Process of Analyzing a Conflict of Laws Case"; an article as part of a symposium in the **Minnesota Law Review**, Uniform Reciprocal Enforcement of Support: 1958 Dimensions," and a book review of the Read-MacDonald Casebook on Legislation in the **Journal of Legal Education**.

The Phi Delta Phi senior award was given to Richard Bodine.

The U. S. Law Week Award for the senior making most satisfactory scholastic progress was won by Fred G. Thelander.

William King has contributed material from "Use of Mob Violence Statutes as a Remedy in the Protection of Civil Rights" for use in an article for the **Race Relations Law Reporter**.
