



SUPREME COURT JUSTICE CLARK

GUEST OF HONOR AT LAW DAY

The activities of the sixth annual Law Day celebration at the Indiana University School of Law on May 4 were climaxed at the evening banquet by a speech by Mr. Justice Tom C. Clark, Associate Justice of the United States Supreme Court. Earlier in the day, Mr. Justice Clark, together with the Honorable William E. Steckler, Chief Judge of the United States District Court for the Southern District of Indiana; the Honorable Jesse E. Eschbach, Judge of the United States District Court for the Northern District of Indiana; and the Honorable Willis Hickam of Hickam & Hickam, Spencer, Indiana, and President of the Board of Trustees of Indiana University, served on the bench for the moot court competition and was honored at a reception in the School of Law lounge.

In his speech Mr. Justice Clark asked practicing attorneys and law school faculties to take a greater interest in achieving a solution to the growing problem of providing proper legal counsel for indigent defendants. He cited recent United States Supreme Court decisions which have expanded the rights of such defendants, most notably the *Gideon* case which secures the right of the indigent to counsel in non-capital felony cases. As possible solutions, Mr. Justice Clark suggested that the bar associations should not leave the defense of the indigent defendant to the young, inexperienced lawyer, the law schools should place greater emphasis on

the teaching of criminal law and procedure, and the use of student clerk programs to aid the practicing attorneys with the counsel and the defense of indigent defendants.

Gavel Award

One of the highlights of the day's activities was the presentation of the Gavel Award by the Bloomington Division seniors to Ritchie G. Davis, Associate Professor of Law. The Gavel Award, given annually to the nonstudent who makes the most outstanding contribution to the School of Law, is a highly coveted law school award. Professor Davis, who received an A.B. degree from Ohio Wesleyan University in 1935 and a J.D. degree from the University of Chicago in 1939, joined the Indiana University law faculty in 1947 after serving as an Associate Legal Counsel in the United States Navy from 1942-46. Prior to entering military service, he practiced law in New York City and taught on the law faculty at the University of Texas.

Moot Court Competition

IRS COMMISSIONER, JURIST ARE 1963 HARRIS LECTURERS

The first of three 1963 Addison C. Harris Memorial Lectures was held at the Claypool Hotel in Indianapolis on January 24 during the mid-winter meeting of the Indiana State Bar Association. Mortimer C. Caplin, the Commissioner of the Internal Revenue Service (during the Kennedy Administration), spoke on the topic "The Settlement of Tax Controversies." Mr. Caplin, a Professor of Law specializing in the area of Federal Income Taxation and author of such works as "Doing Business in Other States" and "Estate Plans," is presently on leave of absence from the University of Virginia School of Law. (He practiced law in New York City for nine years prior to entering the teaching profession.) On the evening of his lecture, the Commissioner was guest of honor at a banquet attended by members and their wives of the Indiana State Bar Association and the faculty of the School of Law.

The speaker for the other two Harris Lectures, held on April 19 in the Moot Court Room of the Bloomington Division Law Building, was Dr. Albert van Houtte, a Belgian, who, since 1958, has served as Clerk of the Court of Justice of the European Communities. His subjects for the afternoon and evening lectures, respectively, were "The History and Development of the Court of Justice of the European Communities" and "Capita Selecta from the Jurisprudence of the European Court." Dr. van Houtte, a Doctor of Laws and Licentiate in Political and Social Economy from the University of Louvain, served more than five years as Clerk of the Court of Justice of the European Coal and Steel Community prior to his appointment to his present position. (He has also served as head of the Cabinet of the Belgian Minister of Agriculture and as Secretary of the European Bureau, then as President of the Belgian National Committee, of the Food and Agriculture Organization.) (Coffee hours were held following each lecture in order that students, members of the faculty and practicing Bar and others in attendance at the lectures might meet Dr. van Houtte personally.)

LEGAL CAREER CONFERENCE

On December 11, 1962, the fourth annual Legal Career Conference was held at the Bloomington Division of the Indiana University School of Law. The program, which is sponsored by the Young Lawyers Section of the Indiana State Bar Association, is intended to acquaint law students with the various types of law practice and the rewards and problems accompanying each type.

The young attorneys participating in this year's conference were James A. Briggs of the Indianapolis firm of Briggs and Berner; Roger Brown, a single practitioner in Jasper, Indiana; Robert D. Patrick, Assistant General Counsel for Mead Johnson and Company, Evansville, Indiana; W. Jack Schroeder, who is associated with D. Bailey Merrill in Evansville and who was the general chairman and organizer of the program; and William P. Wooden, an associate with the Indianapolis law firm of Barnes, Hickam, Pantzer & Boyd.

Each participant gave a general description of the type of practice in which he is engaged, including such matters as the type and amount of work; general nature of the firm's clients; social contacts with other members of the firm, clients, and the Bar; compensation to be expected; necessary initial investment; and how to get into practice.

A question and answer period followed the presentation by the panel members, during which time several of the students in attendance received answers to specific problems which were troubling them. The program was well received by the law students who felt that the full and frank discussion of the life of young attorneys in various types of practice was most helpful to them in planning their own legal careers.

TO THE ALUMNI OF INDIANA UNIVERSITY SCHOOL OF LAW..

Since the last Annual Meeting of our Association, held during Commencement week-end in June-1962, the Law Alumni Association participated with the Indiana State Bar Association in a luncheon meeting held at the Edgewater Beach Hotel in Chicago, at which President Elvis J. 

FACULTY NEWS

At the annual meeting of the American Bar Association in San Francisco August 3-9, Dean Leon Wallace was elected Vice Chairman of the section on Local Government Law. He attended the Section's New Orleans meeting during February. He was also elected to the Council of Local Government Law section of the Indiana State Bar Association at the Association's Annual meeting in Chicago September 12-15.

During the past summer Professor F. Reed Dickerson served as Consultant to the Federal Aviation Agency in Washington, D.C., assisting in the reorganization of the Agency's legal department.

Professor Ralph F. Fuchs was a member of the Administrative Conference of the United States, which rendered its final report to President John F. Kennedy in December 1962. The Conference consisted of government and non-government lawyers, together with several political science and law teachers. An article summarizing the work of the Conference, written by Professor Fuchs, is in the current issue of the Administrative Law Review of the Section on Administrative Law of the American Bar Association.

Professor Jerome Hall returned to the School of Law February 1962 from Europe after serving as Visiting Professor at the University of Freiburg, Germany, and after completing several months' research in London and Paris. A supplement to his case book on criminal law was published in May by the Bobbs-Merrill Company, Indianapolis.

Professor Harry Pratter participated in the discussion of the Uniform Commercial Code in the Commercial Law Institute at the September meeting of the Indiana State Bar Association in Chicago. Professor Pratter has given several talks on The Code to County Bar Associations as well as prepared part of the Annotations to and Comments on the Code.

From June 1 through October 1, 1962, Professor W. J. Wagner traveled around the world on a lecture tour organized by the United States State Department. He visited more than 24 countries in the Caribbean, Africa, Europe, and Asia, speaking in English and French on various topics in the fields of law and government. While in Seoul, Korea, he delivered a short (12-hour) course on Torts at the Graduate Law School.

Professor Betty V. LeBus, Law Librarian, served as President of the Indiana Library Association during 1961 and 1962. Miss LeBus is also Chairman of the American Association of Law Libraries Scholarship Committee.

Mr. Jurij Fedynskij, Assistant Law Librarian and Research Scholar in Law, is currently serving as Secretary for the International Association of Law Libraries. He gave lectures on the law of contracts and on the law of torts in the Soviet Union at the Institute on the Law of Communist Countries held at the School of Law in Bloomington during March.

Professor William W. Oliver received the University Foundation Teaching Award during the Founders' Day program on May 1.

Law Club


