O'NEAL NAMED LAW FUND CHAIRMAN

The selection of **Perry E. O'Neal, '15**, prominent Indianapolis attorney, as the National Chairman for the Indiana University's 1965-66 "Law School Fund" campaign was announced jointly by Dean **Leon H. Wallace, '31**, Dean **Ben F. Small, '43**, **Carl Overman, '52**, President of the Law Alumni Association, and **William S. Armstrong**, Executive Director of the I. U. Foundation. In accepting the position, Mr. O'Neal noted, "The efforts to maintain and further the high quality of legal education for which I. U. is known is dependent upon the loyal support of the alumni and friends of the Law School. I am honored to have been chosen as head of this year's campaign and hope that the response to our appeal will be as enthusiastic and generous as it has been in the past." He succeeds **John S. Hastings, '24**, Chief Judge of the U. S. Court of Appeals for the Seventh Circuit in Chicago and the national chairman of the 1963 and 1964 campaigns.

O'Neal is the senior partner in the law firm of Thompson, O'Neal & Smith. Following his graduation from I. U. Law School in 1915, he returned to his hometown, Rushville, to practice law until the hostilities of W.W.I intervened. Discharged with the rank of Captain in the U.S. Army, he resumed his legal career—this time in Indianapolis. Through the years O'Neal has been an active participant in the affairs and organizations of his community and profession. In 1952-53 he served as President of the Indiana State Bar Association, and he is presently a member of Indiana University School of Law's Visiting Committee.

Alumni Directors Preview Fund Organization

The Board of Directors of Indiana University Law Alumni Association held its annual meeting in Bloomington on Saturday, September 18. President **Carl Overman, '52**, chaired the breakfast, which was devoted primarily to discussion of the Law School's financial needs and the proposed new organization of the Law School Fund campaign.

William S. Armstrong, Executive Director, I. U. Foundation, outlined, for the board's consideration, a plan reorganizing the campaign so that the law school alumni association will play the leading role with the Foundation's assistance. He introduced **Perry E. O'Neal, '15**, the 1965-66 National Chairman of the fund campaign, and Prof. **Harold Lusk**, the Foundation's new legal consultant and coordinator for the Law School Fund.

In his explanation, Mr. Armstrong stated, "The success of the Fund over the past three years indicates that the law alumni are vitally interested in their school and anxious to support it. This proposal comes in response to the many requests from alumni asking how they might help in the fund raising effort. The new program is

designed to get the maximum results with a minimal expenditure of alumni time and effort.

Presentations explaining the School's present fund situation and its future needs and goals were made by Dean **Ray Heffner**, Vice-President and Dean of Faculties; Prof. **Harry Pratter**, Law School Scholarship Committee member; **Richard Curtis**, Foundation's Director of Research and Development; and **Robert Hanning**, law student and Foundation staff member. **Frank B. Jones** of the Alumni Office reported on the Law Alumni Association's yearly activities.

LARGE CROWD ATTENDS BANQUET HONORING FORMER DEAN HENRY WITHAM

A gathering of four hundred and twenty-five alumni, students and faculty of Indianapolis Division of Indiana University School of Law attended a banquet on Saturday, June 26, honoring Dean **Henry Bryan Witham** and his wife. Dean Witham, former Dean of the Indianapolis Division, retired from teaching after twenty-one years of association with the Law School.

At the dinner, the Governor's Press Secretary, **Richard Vandivier**, presented the coveted "Saga-more of the Wabash" award to the Dean on behalf of Governor Branigan. Also presented to Dean Witham was a caricature of "Horse Charlie" which was painted by Gerald Boyce, head of the art department, Indiana Central College and commissioned by the Banquet Committee, chaired by **Harry Stewart**, '51, and **John Holt**, '56. "Horse Charlie" is the legendary character who played a leading role in all of the hypothetical cases used by Dean Witham in his contracts class.

Dean Witham's interest in education dates from the post-World War I years when he was teaching in Iowa and Kansas. He served as principal and later superintendent until 1921, when he entered the law school at the State University of Iowa. Graduating with honors, he began private practice in Davenport, Iowa. Dean Witham returned to teaching in 1926, assuming the dual positions of assistant professor of law and secretary to the law faculty at the University of Tennessee. He was Dean of Law at Tennessee from 1933 until 1944, when he accepted the challenge of the deanship at the newly created Indianapolis Law Division, a consolidation of Indiana Law School of Indianapolis with I. U.'s law program at Bloomington. In 1960, **Ben F. Small**, '43, succeeded to the Dean's administrative duties.

Lusk Joins Foundation

Harold F. Lusk, author of the most widely used textbook on business law, has been named the new legal associate on the staff of the Indiana University Foundation. It was announced by William S. Armstrong, Executive Director of the Foundation, that Prof. Lusk would serve as a specialist on trusts, bequests, patents and other legal matters. The Foundation has been without a staff legal consultant since the death, a year ago, of George F. Heighway, its long-time secretary. Dr. Lusk will have the additional task of coordination the Foundation's program for the Law School Fund Campaign with the Law Alumni Association.

Originally, a practicing attorney in Grand Rapids, Michigan, after graduation from the University of Michigan Law School, Prof. Lusk was a member of the Indiana University's School of Business faculty for 33 years and last year was a visiting professor at the University of South Florida in Tampa. During his teaching years at I.U., he received the Frederick Bachman Lieber Award for teaching excellence and a merit award from the American Business Law Association.

His book, *Business Law: Principles and Cases*, is believed the only major American legal text to be translated in the Soviet Union—and without permission or regard of the copyright. It also has been translated, with permission, into Japanese. He is presently revising the book for its eighth printing.

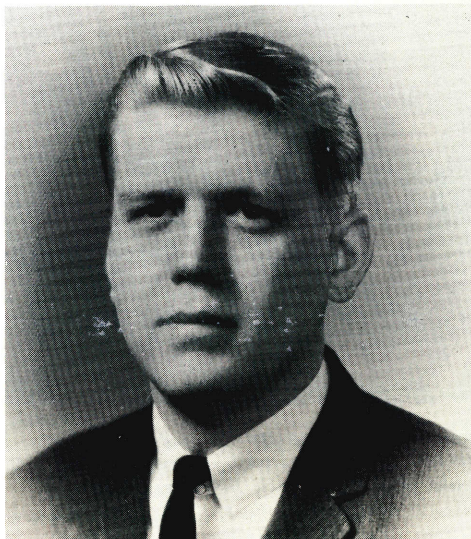

Alumni Named I.U. Trustees

Gov. Roger Branigin has appointed **Jesse Eschbach**, '49, Judge of U.S. District Court of Northern Indiana, and **John E. Early**, '36, an Evansville lawyer, as new members of Indiana University's Board of Trustees. They replace President **Willis Hickam**, '18, a Spencer attorney, and **Robert McCrea**, '39, a lawyer in Bloomington.

Judge Eschbach had to interrupt his law studies to serve four years with the Navy during W.W.II. He returned to I.U. in 1946 and was graduated with honors three years later. A resident of Warsaw, he served as the city attorney and deputy prosecutor. Prior to his appointment to the bench, Judge Eschbach was a member of the law firm of Graham, Rasor, Eschbach and Harris in Warsaw.

Originally from Greenfield, John Early began practicing with Walker and Walker law firm in Evansville following his graduation in 1936. Since 1942, he has had his own practice. Mr. Early twice served as chief deputy prosecuting attorney for Vanderburgh County. He was instrumental in forming the Legal Aid Society in Evansville and served as its first president. Also, he is a past chairman of the young lawyer's section of the Indiana State Bar Association.

Mr. Hickam had been an active member of the Board of Trustees for 12 years, serving half those years as president. Mr. Hickam asked that he not be reappointed since he has reached the age of retirement. A native of Spencer, he has practiced law in his hometown since graduating from I.U., and his son, **Elliott Hickam**, '48, now practices with him. Mr. Hickam has previously been a member of I.U.'s law faculty, a director of I.U. Foundation and Vice-President of the I.U.-Purdue Foundation of Fort Wayne.

Robert McCrea, formerly from Logansport, adopted Bloomington as home after obtaining his A.B. and LL.B. from I.U. He was Monroe County Prosecutor from 1946 to 1951 and Bloomington city attorney from 1952-55.

Lawyers Visited by Student

Continuing the visitation program begun in 1963, the Indiana University Foundation this past summer employed **Bob Hanning**, a second year law student, as traveling representative of the Law School and the University to the lawyers of Indiana. He made trips to Elkhart, Goshen, Indianapolis, Jeffersonville, Kokomo, Marion, Muncie, Mishawaka, New Albany, and South Bend, visiting a total of seventy-five alumni and friends of Indiana University Law School. Through these visits, the lawyers gained a more thorough and current knowledge of legal education at I.U., and in return, Mr. Hanning brought back many suggestions and comments which will be invaluable in assisting the University's administration in its evaluation and development of the Law School.

Mr. Hanning, a native of Marion, ranks at the top of his law class and is presently a Law Scholarship Partner. He was graduated with an A.B. in government in 1962, ending a very active undergraduate career at I.U. While serving as President of the Union Board in his senior year, he received the Arthur L. Metz Scholarship, which is given to a senior man exhibiting the highest qualities of leadership and scholarship. After two years as an officer in the U.S. Army Intelligence, he returned to enter Law School and was awarded a Krannert Fellowship for his first year.

FACULTY'S SUMMER ACTIVITIES ARE VARIED

Associate Dean **Ben F. Small**, '43, was elected President of the International Legal Fraternity of Phi Delta Phi at its 37th Biennial Convention in Quebec, Canada, on September 9. For the past two years, Dean Small has served as the fraternity's international vice-president and has previously held such fraternal positions as regional president and council member. Also elected to an office during the convention was Professor **James R. Gillespie** who is the new President of Province Seven. Phi Delta Phi, the oldest professional fraternity in the country, was founded at the University of Michigan in 1869.

Dean Small with Professors **Cleon H. Foust** and **R. Bruce Townsend** attended the Uniform Commissioner's annual meeting in Miami, Florida. This meeting was held the week prior to the American Bar Association Annual Convention in the same city, which Dean Small also attended. He was joined by Dean **Leon H. Wallace**, '33, and Professor **F. Reed Dickerson** at the convention.

The summer activities of Professor **W. J. Wagner** took him all over the European continent. He was awarded a research grant to study comparative law in tort in the Netherlands. The grant was presented through the I.U. Foundation under the University's Ford International Program. Prof. Wagner did his research at the Documentation Office for East European Law at the University of Leiden.

In addition, his schedule involved participation in a Congress of the French Association for World Law in Nice; the reading of a paper on the origins of the law of defamation in the common law at a conference in Bordeaux; instructing two courses, one being an introduction to American law and the other dealing with the law of torts and contracts in the common law system, at the International Faculty of Comparative Law in Luxembourg; lecturing at the European Federalist College in Italy; participation in the Vienna convention of the International Association of University Professors; and attendance at the Alpbach European Forum in Tirol, where this year's topic dealt with the relations between the U.S. and Europe. Upon his return to the U.S., he stopped off in New York to read a paper on federalism at the Conference on World Peace Through World Law.

Professor Wagner recently had his article, "Right of Privacy in U.S. Law", published in *Revue Internationale de Droit Compare* in Paris, France.

Professor **Daniel J. Baum**'s new book, *The Silent Partners: Institutional Investors and Corporate Control*, co-authored by Ned B. Stiles and published by Syracuse University Press, came off the press September 1st. He was also program coordinator for the first annual national conference on "Law and Business: The Robinson-Patman Act" held September 23-25 at the University of Notre Dame under the joint sponsorship of the Indiana Continuing Legal Education Forum and the Federal Bar Association.

Professor **Jerome Hall** spent this summer as a "Visiting Scholar in Criminal Law" at New York University from June 1 to September 15. The revised edition of his text book, *Criminal Law and Procedure, Cases & Readings*, written in collaboration with Prof. Gerhard O.W. Mueller and published by Bobbs-Merrill Co., Inc., came out this month. The book will be used in the criminal law courses at I.U. this year. Prof. Hall, a Director of the American Society for Legal History, was recently made chairman of the Nominating Committee to select new officers and directors for the society.

Ralph F. Fuchs was awarded the title of University Professor by the Indiana University Board of Trustees. A past general secretary and president of the American Association of University Professors, has been a faculty member since 1945. This past spring, Prof. Fuchs became chairman of a committee of the Association of Law Schools which is to formulate a statement of guides with respect to the establishment of new law schools.

Professor **L.A. Jegen** spoke at several institutes this summer, one of which was the Indiana Estate Planning Council, composed of attorneys, accountants, trust department officers and insurance executives.

Professor **W. Howard Mann** will take a year's leave of absence to accept a Fulbright grant to do research in Indian Federalism. The award was given him under the international education exchange program conducted by the Bureau of Educational and Cultural Affairs of the U.S. Department of State. Prof. Mann will do his research at the Indian Law Institute, New Delhi, India.

Returning from a leave, Professor **Charles D. Kelso**, as Director of the Association of American Law School's "Study of Part-Time Legal Education", visited over 100 law schools last year. Questionnaires have been obtained from both full and part time professors and all 1965 June graduates in the U.S. Also this past year, his book, *A Programmed Introduction to the Study of Law, Part I, Case Skills*, was published by Bobbs-Merrill Co., Inc.

Professor **F. Reed Dickerson** is author of *Fundamental Legal Drafting* sponsored by the American Bar Foundation and published by Little, Brown and Co. The book grew out of the concern of the Foundation with the prevalence of less than perfect legal drafting and the belief that the fundamentals of good legal drafting should be enunciated and made more widely accessible to the bar. The book, his fourth, was dedicated to I.U. Professorial Lecturer **Kurt F. Pantzer** of Indianapolis "for his vision, inspiration and support."

Published in the summer issue of *University of Chicago Law Review* is Professor **Julius G. Getman**'s article, "Section 8(a) (3) of the NLRA and the Effort to Insulate Free Employee Choice."

Bobbs-Merrill Co., Inc., has just released a revised edition of *Cases on International Law*, by Professor **Lester B. Orfield**. Collaborating with him on this edition was Edward D. Re, Professor of Law, St. John's University.

Professor **William W. Oliver** has an article entitled "Income Tax Aspects of Gifts of Business Property in Trust and Lease-back to the Grantor," published in Issue I of Volume 51 of the *Cornell Law Quarterly*.

Professor **Douglass G. Boshkoff** was presented the Gavel Award as part of an I.U. program observing National Law Day. The yearly honor is given to the faculty member voted as the outstanding professor by I.U.'s School of Law student body. Prof. Boshkoff came to I.U. the summer of 1963 as a visiting professor of law from Wayne State University and three months later accepted a full-time appointment.
