Offices. The principal offices is in New York, with branch offices in Philadelphia and Baltimore, for the convenience of the Shareholders.

Selection of Property. The property has been selected with great care during the last three years, by those of the Trustees and Officers who have been constantly operating on Oil Creek, and throughout the entire Oil Region of Pennsylvania, as well as Western Virginia, and was not selected to sell, but for the purpose of development and producing oil; extensive developments having been already in progress of the lands previous to their being put into a Stock Company.

Property. The Company has twenty-six different properties embracing lands in fee simple, leases, and interests and amounting to 635 acres, more or less, every acre of which is bottom land and the best of boring land.

Location of Properties. The different properties are located on Oil Creek, Cherry Run, Cherry Tree Run, Alleghany River, opposite Horse Creek, Sugar Creek, Elk Creek, and other favorite streams, rich in oil in the very heart of the great Oil Region.

Wells. The YANKEE WELL, 200 barrels per day. The AUBURN WELL, 150 barrels per day. SCHEDULE OF PROPERTIES BELONGING TO THE COMPANY.

No. 1 is a tract of land of fifty-seven acres in fee simple, situated on Sugar Creek, Sugar Creek Township, Venango County, Pennsylvania, and known as the Saunders Farm—originally a part of, and the upper end of, the Russell Farm. This property is all flat, and embraces the entire width of the valley, extending from bluff to bluff. This interest carries with it one engine and house, derrick, drilling tools, etc. There is a well being bored on this farm, while two more are going down adjoining above, and two below, one of which is now producing 25-barrels per day of lubricating oil. There is a large house on this property for the accommodation of workmen.

No. 2.—One lease of three lots of ground on Cherry Run, bottom land, within one hundred feet of the sulphur spring on the McFate Farm. This property is most desirably located of any on the Run, being a short distance from the celebrated Read Well, Yankee, Auburn and other wells, now flowing from 25 to 280 Barrels per day. One well down, pumping 10 barrels per day, and another well, down about 400 feet (new well). This property has one well down, producing 15 barrels per day, with room for four more wells, together with one engine, tubing, sucker, rods, tanks, gas-pipe for conducting gas from well to engine, and all the fixtures for continual operation.

No. 7.—One-sixteenth working interest in Lot No. 11, on Steel Farm, with one-sixteenth interest in one engine, 500 feet of tubing, tanks, house, derrick, etc., with one well now going down; present depth 450 feet, with a flattering show of oit; room for four more wells. All the above property on this farm (viz., Nos. 4, 5, 6 and 7), is of the most valuable oil-producing territory on Oil Creek, with wells on adjoining lots producing from 25 to 240 barrels per day each.

No. 8.—The one-fourth working interest in a lease on the Tarr Farm, with the one-fourth of engine, tubing, tanks, etc., necessary for operating. One well going down. This interest claims one-eighth of all the oil.

No. 10.—Lease of one acre of land on Cherry Tree Creek, adjoining the Dempsey Farm, all flat land, lying on both sides of the Creek. This interest receives three-quarters of all the oil. One engine, derrick, engine-house and necessary fixtures for operating.

No. 11.—One lease on Dempsey Farm, known as Lot No. 25, according to survey of said farm. The interest includes the whole working interest, being one-half of all the oil. One derrick, engine, and all necessary fixtures for putting down a well. Well going down.

No. 12.—A lease of five acres on Sugar Creek, Oakland Township, Venaingo County, Pennsylvania, and known as the David Reynolds' lease, which lease extends for the term of 20 years from the 16th day of September, A. D., 1864. This lease is situated on the bottom lands of Sugar Creek, and without doubt will be in a short time valuable property, as there are a number of wells being bored in the immediate vicinity by Philadelphia Companies. This lease carries three-quarters of all, the oil.

No. 13.—A lease of eleven acres of land on Sugar Creek, all flat land, and known as the Arthamer Davison lease. This property is leased for forty years, giving the land-holders one-seventh of the oil only. There are a number of wells now going down in the immediate vicinity of this farm, some of which have good shows of oil.

No. 16.—Is a lease of a piece or parcel of land situated in Franklin Township, Eric County, Pennsylvania, it being the farm formerly known as the John L. Rhodes Farm, containing about 64 acres, more or less. This property is situated on Elk Creek; already a number of derricks are being erected in the vicinity; prospecting for oil now commenced. There were some three wells sunk in the township, in 1860, to the depth of two hundred feet, with a good show of oil, and now considered good oil territory. Lease is one-half of all the oil produced.

No. 17.—Is a leasehold of a piece or parcel of land situated in Gudgenville, Girard Township, Eric County, State of Peansylvania, and bounded by L. C. Kent, Cortecy and others, containing sixty-four (64) acres, more or less. This property is situated on a tributary of Elk Creek, and is considered good oil territory, in a deep gulf about one mile from the above named creek, carrying with it the one-half of all the oil found. There are a number of oil springs in the immediate vicinity.

No. 18 comprises a leasehold of piece or parcel of land situated in Fairview Township, Eric County, Pennsylvania, containing about ten (10) acres. This property is situated on Elk Creek, favorably located, and carries with it one-half of all the oil produced.

No. 19 is a leasehold of a piece or parcel of land situated in Girard Township, Eric County, State of Pennsylvania, known as the Wilcox Farm, containing about one hundred and eighty acres. This property is located on Elk Creek, in the above township, embracing all the flat land lying between the bluffs on each side of the creek, for about one and a half miles, on which there are good surface indications of oil in gas and oil springs. This lease carries one-half of all the oil.

No. 20 comprises a piece or parcel of land in Franklin Township, Eric County, Pennsylvania, situated on a branch of Elk Creek, known as the Gulf, and part of Howard Farm. This property carries with it one-half of all the oil produced, has one well, sunk in 1860 or 1861 to the depth of 250 feet, with a good show of oil. Oil can at any time be collected from the well.

No. 21 is a leasehold situated in Franklin Township, Eric County, Pennsylvania. This lease contains forty-one acres, and is known as the Pettis Farm. This territory is located on a branch of Elk Creek, known as the Gulf, and is considered some of the best oil territory in the county. There is a celebrated oil spring but a short

No. 23 is a leasehold of a piece or parcel of land situated in Fairview Township, Eric County, Pennsylvania, containing five acres, being part of the John Struth Farm. This territory is located on Elk Creek, embracing the land on both sides of the creek, from bluff to bluff. The location is considered as one of the best on the creek. This lease claims one-half of all the oil.

No. 24 comprises a piece or parcel of land situated in Franklin Township, Eric County, Pennsylvania, lying on Elk Creek, containing twenty-nine acres of land, more or less, known as part of L. D. Allen's Farm. This property is favorably situated on the creek, and all flat land. There are surface oil indications in this tract; in the judgement of oil men will form good oil producing territory.
